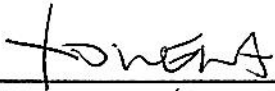

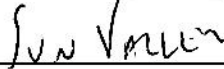

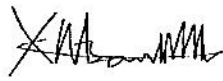

TERMS AND CONDITIONS OF CARRIAGE

- Insurance of high value per full vehicle load should not exceed our standard insurance cover. Should additional insurance be requested such requests must be done in writing (additional insurance cost to be calculated on a pro-rata basis.)
- No full vehicle load to exceed a total mass of 35 000kg. Overloading fines and correcting thereof will be for consignors account.
- Bulk loads where amounts cannot be verified by driver, such shortages within reason will not be entertained.
- Palletized goods (shrink wrapped) or otherwise will be regarded as a single unit. Total contents as depicted (STC ex amount) shortages will not be entertained unless pilfering / damage to packaging is evident prior to off loading.
- Any damages caused en route due to inferior or insufficient packaging will not be entertained.
- All discrepancies / shortages must be reported to our office(s) prior to departure and / or subsequent off-loading.
- No second hand machinery / equipment will be covered by transporters insurance, consignor to ensure such goods are covered.
- Any goods conveyed where full description is not disclosed leading to criminal action being taken whereby vehicle / goods be impounded or driver charged, all legal costs will be for consignor's account.
- No perishable (refrigerated or frozen goods), live-stock, arms and ammunition, tobacco goods or other dangerous goods (explosives) shall be transported by Sun Valley Transport.
- All claims to be lodged within 24 hours per email.
- All relevant documentation pertaining to a claim must be made available within 30 days.
