Figure 1 consists of 12 sub-graphs, labeled (a) through (l), each showing the percentage of correct responses (Y-axis, 0 to 100) versus the trial number (X-axis, 1 to 12). The graphs represent different groups of subjects based on their initial performance level. Groups (a) through (j) start with initial correct response percentages of 100%, 90%, 80%, 70%, 60%, 50%, 40%, 30%, 20%, and 10% respectively. Groups (k) and (l) start at 0%. In all cases, the percentage of correct responses generally increases over the 12 trials, with the rate of improvement being more pronounced for groups with lower initial performance. For example, group (a) remains near 100% throughout, while group (l) starts at 0% and reaches approximately 80% by trial 12.
