The t-statistic for the slope coefficient is 10.5, and the p-value is 0.0001. The F-statistic is 110.25, and the p-value is 0.0001. The Durbin-Watson statistic is 1.8. The adjusted R-squared is 0.83. The total number of observations is 10.

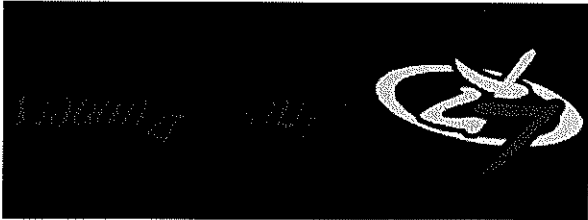
