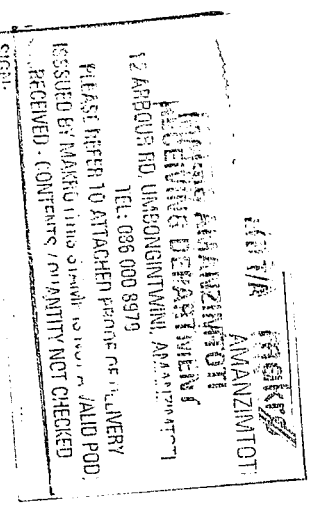

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were cultured in the YEA medium for 24 h. The cell concentration of the strains was adjusted to 10⁸ cells/ml. The cell suspension was mixed with the plant tissue and the transformation efficiency was determined. The results were expressed as the mean ± SD of three independent experiments. The asterisks indicate the significant difference between the strains.

Figure 1 shows the effect of 100 nM 17β-OH progesterone on the phosphorylation of p38α and p38β. The figure is a 3x3 grid of Western blot images. The columns are labeled 'p38α', 'p38β', and 'p38α/p38β'. The rows are labeled '0 min', '15 min', and '30 min'. Each blot has two lanes: a control lane (left) and a treatment lane (right). The ratio blot shows a single band for each lane, with the treatment lane showing a higher ratio (shifted to the right) compared to the control lane, indicating an increase in the phosphorylated form of p38α relative to p38β over time.
