



However we are unable to remove the below 5 units without damaging the barcode and the bottle label.

How does upliftments gets authorized? Dose it get inspected by the rep first before issuing the upliftment?

How can this be resolved as I cannot put / credit the stock back for resale with the bottles looking like this unless it gets returned to the customer or written off for your sales team to use as tasting stock etc.






