Metaphase: The chromosomes are aligned vertically along the center of the cell (the metaphase plate). 3. Anaphase: The sister chromatids have separated and are being pulled toward the left and right poles of the cell. 4. Telophase: Two new nuclei are forming at the poles, each containing a set of chromosomes. 5. Cytokinesis: The cell membrane is pinching inward at the center, dividing the cell into two daughter cells.
